SPORTS AUTHORITY OF INDIA, NSSC, BANGALORE

REPORT ON THE VISIT OF SECRETARY (SPORTS), MINISTRY OF YOUTH AFFAIRS AND SPORTS, GOI AND DIRECTOR GENERAL, SAI, NEW DELHI ON 22ND AND 23RD MARCH 2017 TO SAI NSSC BENGALURU.

I MEETING WITH FOREIGN COACHES AND NATIONAL COACHES ATTACHED TO NATIONAL COACHING CAMPS:

- 1. The Secretary (Sports), MYAS, GOI and DG SAI, briefed that the purpose of the meeting was to assess the progress of ongoing National Coaching camps and to obtain feedback on further requirements, if any. In this connection, Secretary (Sports) pointed out that India has got a lot of potential but the same is not optimally transformed into performance. Hence, greater attempts are to be made to bridge the gap between talent and performance. Below par performance at International competitions points out at the need for improvement in different aspects of athlete support system. All the Federations are supported by the Government but there are serious issues of accountability. There should be a two-way accountability in the approach towards sports persons and performance.
- 2. The Olympic Task Force constituted by the Government is in the process of preparing perspective plans for Olympics 2020, 2024 and 2028, which should be put into operation immediately. Talent identification and Junior Development programme are as important as the ongoing National camps. There are gaps in the requirement of infrastructure, human resources, equipment, sports science back up etc., and every effort has to be made to fill up these gaps.
- 3. A strong monitoring and evaluation system is required for accomplishing these plans, which should enable maximum utilization of the potential and available facilities. Top most training centres for individual disciplines should be established for handling the best talent available and issues of doping should be dealt with very seriously. Proper attention should be given for prevention and management of injuries and physical fitness.

- 4. Secretary (Sports) & DG, SAI observed that it appears some of the sports persons are going for major competitions with injuries. The fitness profile of athletes should be monitored during the camp. The coaches attached to the camp and medical team should take the responsibility of not allowing the injured sports persons to go for competitions. Rehabilitation camps for the injured athletes may be organized. It was also pointed out that some of the athletes take treatment outside without informing the Sports Medicine department of this centre. The coaches attached to the National camps should make it mandatory to inform / record all injuries and related issues to the Sports Medicine centre so that the incidents referred above will not occur in future.
- 5. Incidents of National campers leaving the camp without permission was brought to the notice of the Secretary (Sports) & DG, SAI to which it was informed that if any camper leaves the camp without permission, he/ she may be expelled from the Camp. The matter will be taken up with the Federations concerned.
- 6. Insurance coverage shall be made compulsory for National campers and coaches. TEAMS division, SAI Head Office, shall convey insurance coverage details to concerned centres / camps immediately.
- The Coaches attached to National camps are required to maintain discipline of athletes in the camp including attendance.

II MEETING WITH SECTION HEADS

- 1. Secretary (Sports) & DG, SAI, while addressing the section heads stressed upon the importance of talent identification and Junior Development programmes. Talent identification programme has to be planned at the Regional centre level. The Junior Development programmes should be time bound and outcome oriented. Academic programmes should be based on the demand. We should concentrate on priority disciplines. A perspective plan covering all areas of functioning of the centre should be prepared for the next 10 years. SAI NSSC Bengaluru centre should become a role model for practical application of sports sciences, especially for National teams. Integration of Sports Sciences with the coaching system is essential.
- 2. It was brought to the notice of the Secretary (Sports) & DG, SAI that running of certain STCs in the region has become difficult due to insufficient facilities, lack of adequate support from the State Govt. and difficulties being faced by SAI for taking up the maintenance works in the absence of sufficient funds and proper MoU with the State Government. The Secretary (Sports) & DG, SAI informed that NSSC may identify the non performing centres and plan shifting the inmates to the nearby performing centres. The STCs have to be classified accordingly and a specific proposal shall be sent for approval.
- In order to utilize the facilities of GTMT department more effectively for National camps, the proposal for engaging two research fellows was approved in principle subject to finalization of the QRs.
- 4. It was brought to the notice of the Secretary (Sports) & DG, SAI that budget allocation under the major head "Maintenance of Stadia Building" is insufficient as only Rs.350 lakhs was allocated against the actual expenditure of Rs.450 lakhs. Further, additional expenditures like maintenance of Hockey turfs (Rs.24 lakhs), outsourcing maintenance of Swimming Pool, hydrotherapy, horticulture etc., would cost an additional expenditure of Rs.276 lakhs making the total requirement during 2017-18 to Rs.750 lakhs (approx). The Secretary (Sports) & DG, SAI advised to send a demand for the Field of play (FOP) charges, which is at present retained at the SAI

Head Office, for meeting the additional expenditure for the conduct of National camps in Hockey towards watering of play field and flood lighting, etc.

5. The Guest Flats should be upgraded where foreign coaches are being accommodated and the expenditure shall be met out of the concerned sub head of lodging expenditure for foreign coaches. Providing accommodation to foreign experts in the SAI Guest Flats lead to lot of savings of expenditure compared to accommodating them in hotels and providing transportation on daily basis.

- Action may be taken for starting Massage course at SAI NSSC as proposed by SSO(SM).
- 7. The Javelin throwers attending the camp may be allowed to procure Javelins themselves whenever they go abroad for competitions / training as it was done in case of Archers.
- 8. The Secretary (Sports) & DG, SAI informed that Government has decided to release grants on the basis of Monthly Expenditure Plan (MEP) and therefore all the units of SAI are required to plan meticulously and send the monthly expenditure and budgetary requirement efficiently.

- VII. CREATION OF WORLD CLASS MODULAR KITCHEN AND DINING FACILITY FOR NATIONAL CAMPERS AT SAI NSSC BANGALORE MEETING WITH OFFICIALS FROM TATA STEEL LTD AND TAI SATS
- 1. The Secretary (Sports), MYAS, GOI and DG, SAI had a meeting with Shri Sunil Bhaskaran, Vice President, Tata Steel, Shri Farzan R Heerjee, Chief Protocol and Special Projects, Corporate Services, Shri Mukul Choudhury of TATA Steel Limited, Shri Sagar Dighe, COO, TAJ SATS along with Shri Vishal Chauhan for discussion on creating a world class catering facility for the National campers at SAI NSSC. Shri Bhaskaran volunteered to help in planning the facility. The Secretary (Sports) & DG, SAI observed that the facility to be created should be minutely planned covering all aspects viz., procurement, quality control, processing, cleaning, hygienic way of cooking as per the entitled dietary requirement of various groups of National camps, serving, maintenance of general cleanliness, scientific and eco friendly way of waste disposal, aesthetic appearance etc. A centralized space to be identified where a common catering infrastructure can be created for dining facilities for all groups covering Male and Female sports persons, Foreign Coaches, National coaches, other experts, visiting dignitaries, organizing banquets etc.
- The facilities should be planned for a scientific catering based on required nutritional values as per the requirement of sports persons. Once the facility is created at this centre, the same can be made at other SAI centres where National camps are held.

VIII. INAUGURATION OF HYDROTHERAPY FACILITY:

1. The Secretary (Sports), MYAS, GOI and DG, SAI inaugurated the newly created Hydrotherapy facility at the Sports Medicine centre at 10.30 a.m. on 23rd March 2017. The project costing Rs.45 lakhs is designed to provide faster rehabilitation to the sports persons by means of hydrotherapy pool with rotating nozzles, hydro massage jet and counter current mechanism.

- 2. Automatic temperature control system and dedicated filtration plant unit are part of the facility. Jacuzzi and steam bath units are also installed in the room as additional provisions. The Secretary (Sports) has agreed to the proposal for entering into a five years annual maintenance contract with the supplier.
- 3. The facility is unique of its kind in SAI and the Secretary (Sports), MYAS desired that such facility to be created in all SAI centres where National campers are being held and scheduled to be held.
