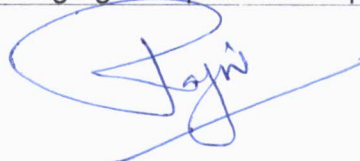

Termination of engagement	(a) Ministry of Youth Affairs and Sports may terminate the services of the Consultant, if (i) The Consultant is unable to accomplish the assigned work (ii) Quality of the accomplished work is not to the satisfaction of MYAS (iii) The Consultant fails in timely achievement or the milestones a decided by MYAS (iv) The Consultant is found lacking in honesty and integrity (v) The requirement of Consultant for the work assigned ceased to exist (vi) The undertaking given by the candidate is found false (vii) If the competent authority in the MYAS for any reason does not find the Consultant suitable for the job. (viii) Contract may be terminated by MYAS without prior notice in the event of failure in performance. (b) The decision of the competent authority shall be final and binding on the Consultants. (c) If any Consultant want to resign from the post, (s)he have to give one month notice in writing.
16.	Medical Fitness and Police Verification:	Police verification will be conducted after the engagement of the Consultants and before joining in the Ministry, the Consultants will also submit, a medical fitness certificate from an authorized/registered Medical Practitioner, at the time of joining.
