### REPORT ON VISIT OF UNION SECRETARY (SPORTS) CUM-DIRECTOR GENERAL, SAI TO GUWAHATI, ASSAM ON 3<sup>RD</sup> AND 4<sup>TH</sup> JANUARY, 2017

I made a visit to Assam to discuss development of sports in Assam. During my visit, I assessed preparedness of Assam for holding the FIFA U-17 Football World Cup and the Himalayan Region Sports Festival (HRSF) and visited the venues. I also visited Sports Authority of India (SAI) Regional Centre, Guwahati, and Lakshmibai National Institute of Physical Education (LNIPE) North Eastern Regional Centre (NERC), Guwahati, and held discussions with the local incharge. I was accompanied by Shri Onkar Kedia, Joint Secretary Sports, Shri Subhash Basumatary, Regional Director SAI RC, Guwahati, and other officers of the Government of India, Department of Sports, and SAI.

#### 3RD JANUARY

#### A. FIELD VISITS

(a) My first visit was to the Indira Gandhi Athletic Stadium Football Ground for FIFA U-17. I discussed the preparedness of the venue for competitions with Shri Ajay Tewari, Commissioner & Secretary, Department of Sports & Youth Welfare, Government of Assam and his team of officers. They apprised me that the ground has to be made FIFA compliant and handed over to FIFA by March, 2017. The overall progress is satisfactory. It was also decided that this ground will host the Football matches under the HRSF too. The Ground also has a track around it and therefore the Athletic events under HRSF can be held here.

This was followed by discussions with the officers of the Assam Government on how to make Assam the sports capital of North East India. During the discussions the following salient points emerged:

- i. Indian Sports is at the crossroads today. Though the country is demographically well endowed, the country is yet to become a world beater. The meteoric rise of Indian cricket proves that India has the mettle to become a frontrunner in Sports. The success of Cricket, however, has not been replicated in any other Sports. Sporadic sparks of sporting brilliance at the international level have reinforced the position of India as a giant slayer. However, such success have come not because of any system but inspite of it.
- ii. While winning medals in Olympics is the ultimate objective of all Sporting nations, this cannot happen overnight. It is essential to converge efforts of all stakeholders and actors in Indian Sports through a single Sports Plan with clearly defined objectives and demarcation of responsibilities between all stake holders, i.e., the Central Government including the Sports Authority of India, the State Government, The National and State Sports Federations, NGOs, PSUs, Corporate Sector, Sports Industry, Education System (Schools, Institutions, Colleges and Universities), etc. The Plan should have measurable outcomes and work towards the common cause of sports development in India. This will avoid multiplicity of the same tasks and instead of each entity working in silos, there will be a

convergence of efforts, thereby leading to optimum utilisation of resources and effective outcome.

- iii. It is felt that while there should be an overarching National Sports Vision, the States will have to formulate compatible State visions which can synergise with and feed the National vision. Either State Government or Central Government can play the anchoring and catalysing role, but this has to be done professionally. This Vision is envisaged to make sports attractive enough as a sustainable career alternative to attract talent from all economic strata of society and put in place a uniform system throughout the country from beginning to end to prepare medal winners by creating a large pool of qualified and competent coaches who will emerge through a system of training and capacity building.
- iv. With regard to achieving excellence in Sports, the first priority would be to increase the number of athletes qualifying and participating in the Olympics. The next step would be to participate and do well in the Olympics. Once this is achieved, with some more effort, the chances of winning medals in Olympics can be increased manifold. Therefore, focus should be on such sports disciplines which have low cost of training and low level of competition both at continental level and at global level.
- v. While much of Sports administration at the ground level is with the Sports Federations, the Government can identify and nurture sporting talents. Identification and grooming of talent is a money making enterprise, especially in Football in Europe. The same method can be adopted in India as well. A welcome change is that now, professional players can participate in the Olympics as well.
- Each State, should, therefore, set up a Task Force to thrash out modalities for sports vi. development through a focussed and result oriented action plan. For Global competition, each State should identify priority sports disciplines, preferably limited to four and set up National Level Sports academies for these Sports disciplines. Such academies should have an all India character, akin to the IITs/IIMs. Sports disciplines selected should be such where the State has core strength and a sustainable supply chain. Ideally, 3 individual sports disciplines and one team games can be adopted so that a focussed and result approach, with measurable outcomes, and well defined timelines, can be adopted. The Academies should have state of the art infrastructure with complete specialised support in terms of Sports Science, Sports Medicine, Sports Psychology, Sports Nutrition, etc. Latest techniques of Talent Identification (TID) and Long Term Athlete Development (LTAD) to groom raw talent and mould them into Olympic podium material need to be incorporated in functioning of the Academies and they should be funded commensurately. Sports in the country should progress from community sports development, through broadbasing to achieving international excellence. This should cover a total period of 12 years covering short term (4 years), middle term (8 years) and long term (12 years) approach. Children should be evaluated scientifically and groomed accordingly.
- vii. Besides, Sports is an interesting sector which gives exposure of education, event management, spots industry, sports science, social development, national integration. It has tremendous potential for growth in the country. It is, therefore, imperative that a robust system with adequate emphasis on all relevant parallels and verticals, involving all stakeholders and actors, is put in place to achieve the objective of Sports development in India.
- viii. Assam is a sports powerhouse and also a hub for the North Eastern Region. It hosts the North Eastern Regional Centre of the Sports Authority of India (SAI). It has co-hosted the 12<sup>th</sup> South Asian Games (SAG), 2016, with Meghalaya and is gateway to the North Eastern Region. It is one of the venues for FIFA Under-17 Football World Cup, 2017 and also slated to host the 1<sup>st</sup> Himalayan Region Sports Festival (HRSF). Therefore, development of

Sports in Assam would pave way for development of Sports in the entire North Eastern Region, where Sports is a way of life and which has produced a number of eminent Sportspersons.

Thereafter, I visited the Nabin Chandra Bordoloi Indoor Stadium, IG Athletic Stadium Complex, Sajusarai. The infrastructure in the Stadium was in good condition and it was decided that Boxing matches under the HRSF will be held in this stadium.

(b) My next visit was to the Squash Centre at R.G.Baruah Sports Complex, Nehru Stadium. The Squash Centre is a State-of-the-Art centre with excellent squash courts. Accordingly, squash competitions under the HRSF will be held at this Centre.

I also assessed the condition of the football field at Nehru Stadium. The field is not FIFA compliant yet. Officers of the Assam Government apprised me that FIFA officials have visited this ground which is slated to host FIFA U-17 Football World Cup matches and the ground is being made FIFA compliant under guidance of the FIFA. It was decided that this ground can be one of the practice venues for HRSF.

Thereafter, I evaluated the condition of the Desh Bhakta Tarun Ram Phukan Indoor Hall in the complex and found it suitable for holding Judo competitions under the HRSF.

(c) My next visit was to SAI Regional Centre, Guwahati. Here I visited each of the facilities existing in the complex.

It was decided that upgradation of the SAI Football Field which is being retrofitted with underground drainage and sprinkler systems should be completed expeditiously so that it is in a state of readiness before the HRSF. It was also decided that though the present proposal is to have lighting of 300 lux as required for training, it needs to be upgraded to 1200 lux, being the minimum requirement for holding international matches as well. It was further decided that this field can be one of the practice venues for the HRSF.

I noticed that the SAI Multipurpose Hall does not have any name as is the case with other Indoor halls in the city. I therefore proposed that this hall can be named as TIKHOR Hall and inaugurated by the Hon'ble Chief Minister of Assam. A proposal may be put up by SAI RC, Guwahati for the purpose.

I found that the weightlifting facility at the complex was adequate for practice purposes and it was decided that this facility can be an alternate facility for practice purposes during the HRSF.

(d) My last field visit for the day was to the Bhogeshwari Phukananai Indoor Hall. This hall has excellent facilities for holding both competitions and practice sessions for Weightlifting and hence it was decided that this will be the venue for Weightlifting under HRSF.

#### B. MEETING WITH HON'BLE CHIEF MINISTER OF ASSAM

I had a meeting with Hon'ble Chief Minister of Assam, where Hon'ble Sports Minister of Assam, Chief Secretary of Assam, Commissioner & Secretary, Youth Affairs & Sports, Government of Assam, Joint Secretary (Sports) and other senior officers of the Government of India and the State Government of Assam were present.

I briefed the Hon'ble CM of the field visits that I had made, discussions I had had with officers of the Government of Assam and observations that I had made. Both the Hon'ble CM and the Chief Secretary urged for more support of the Government of India for development of Sports in Assam. Holding of the 1<sup>st</sup> HRSF was and setting up of TIKHOR park was also discussed. The following decisions emerged from the discussions:

World Women Boxing is slated to be held in India with participation of about 400 Boxers from 50 countries. Boxing Federation has approached the DOS for potential venues. They can be asked to consider venues in Assam as an option.	
Efforts are on in the Government of India at the highest level to integrate sports and physical education with the academic education system at schools, colleges, institutions and Universities. It is imperative that as in strong sporting nations like the USA, college sports needs to be given a strong fillip as it helps mature talent identification and forms the feeder for high performance athletes. The Association of Indian Universities (AIU) has a limited footprint in this area. Therefore, Assam can take the initiative to bolster college sports through inter-college competitions. Basic sports infrastructure in the form of playgrounds can be developed using the MGNREGS funds. This will generate employment as per the objectives of the MGNREGA and also help develop playgrounds in all 26000 villages of the State.	State Govt. of Assam
A National Playing Fields Association of India (NPFAI) has been set up by the DOS. States can form their own Playing Field associations. All playgrounds can be registered with the State Playing field Associations which will be integrated with the NPFAI database. This action will have three advantages, viz, it will be difficult to divert the fields for other purposes once they are legally registered, it will provide a platform for longterm athlete development by forming a catchment area for budding talent, and it will help connect the community through regular sports activities. Sports Science is a big sector. The National Sports University (NSU), Manipur, being set up by the DOS has 13 Departments under 4 schools. However, all the Departments will not be located in Manipur. Care should be taken to ensure that height of the statue is optimum to ensure easy visibility from approaching vehicles. To conceptualise the design and make the project attractive, services of experts, including artists of prominence may be engaged. It is expected that the new concept would entail a total financial implication of Rs.1.50 crore. Accordingly, a detailed proposal may be submitted by the Govt. of Assam to the DOS for consideration of additional funding.	

#### 4th JANUARY

### VISIT OF LAKSHMIBAI NATIONAL INSTITUTE OF PHYSICAL EDUCATION, NORTH EASTERN REGIONAL CENTRE, TEPESIA

I visited the LNIPE North Eastern Regional Centre (NERC), Tepesia, on 4<sup>th</sup> January, 2017. After the welcome address by Dean, LNIPE, NERC, I took this opportunity to address the students of the Institute and try to infuse enthusiasm and imbibe a spirit of discipline and focus among them. I reminded the students that Sports is a dynamic and rising sector with numerous verticals and parallels and assured them that they had chosen a good career option by choosing an eminent institute in the form of the LNIPE.

I exhorted them to make the most of the facilities, infrastructure and knowledgeable faculties in the Institute and to grab every opportunity to make the most of resources available in order to acquire requisite domain knowledge and achieve excellence, emphasize on quality education as against mere degree acquisition, enjoy their studies in order to imbibe the knowledge being imparted, and be prepared to take on leadership roles in various capacities, especially as

coaches and Sports managers, and as a consequence, honing of essential skills during their 4-year stint in the Institute was of utmost importance. to harness the true potential of Sports, which holds a very crucial position in society.

I reminded all that Sports is arguably the only activity which demands marshalling of both physical and mental faculties in order to achieve excellence and emphasised the role of Sports in confidence building, character development, social development, community building and National building.

I advised the students to make their learning experience a holistic one so that as Sports leaders, they could address the problems ailing Sports in the country and put in place requisite systems that would help the country achieve excellence in Sports

I advised the Dean to explore the option of identifying components of the present B.Ped course common with other relevant courses like coaching and Sports Management and combine them into the 4-year curriculum so that on completion of the same, the students would have expanded their knowledge base and also would be more employable.

Thereafter, I visited the facilities at the Institute and found that the football field is being upgraded. It was decided that expeditious action on development of Football Ground with Change rooms and Archery Range has to be taken by the LNIPE, NERC from the budget available with LNIPE, Gwalior. LNIPE, Gwalior may be instructed accordingly by the Department. Archery and Fencing under HRSF may be held at the facilities of the Institute.
