Sub: Revocation of suspension of Paralympic Committee of India; acceptance of election for the term 2019-2023; and renewal of recognition of Paralympic Committee of India – reg.

Madam / Sir,

I am directed to refer to Paralympic Committee of India's letters dated 11.05.2020 and 17.11.2020 and to state that after considering the relevant and material facts, such as that the Order dated 06.09.2019 of District Registrar of Societies, Bengaluru being stayed by the Hon'ble High Court of Karnataka by order dated 27.09.2019 passed in Writ Petition No. 43746 / 2019; that the term of the Executive Committee in which Shri Rao Inderjit Singh was President is over on 07.10.2019; and that the Hon'ble High Court of Delhi in Writ Petition No. 10647/2019 on 27.01.2020 has allowed the declaration of results of the election notified on 03.09.2019 subject to the further orders to be passed in the said petition, it has been decided to revoke the suspension of Paralympic Committee of India with immediate effect.

2. I am further directed to say that the election result of Paralympic Committee of India declared by the Returning Officer on 31.01.2020 have been accepted by this Ministry subject to further orders of Hon'ble High Court of Delhi in Writ Petition No. 10647/2019 and other Court order, if any. Accordingly, following office bearers who have been declared elected are taken on record:

- (i) Dr. Deepa Malik, President
- (ii) Shri Gursharan Singh, Secretary General
- (iii) Shri M Mahadeva, Treasurer



3. Upon consideration of the entire matter, it has also been decided to renew the recognition of Paralympic Committee of India for one year from the date of issue of the letter, which will be subject to orders to be passed by the Delhi High Court and High Court of Karnataka or any other Court in the pending matters.

4. It has been noticed that constitution of the Paralympic Committee of India needs to be aligned in line with the provisions of the National Sports Development Code of India, 2011 (Sports Code). Accordingly, the Paralympic Committee of India is required to make categorical affirmation of the provisions of the Sports Code in its constitution **within 6 months** so as to bring the same fully in line with the Sports Code. The Federation is also required to take necessary steps for uploading of the information in compliance to the instructions as contained in this Ministry's letter no. 9-7/2014-SP.I dated 26.02.2015 on suo-moto disclosure within 3 months' time (copy enclosed).

This issues with the approval of competent authority.

Sub: Information to be hoisted mandatorily by IOA & NSFs on their website – reg.

Sir,

Reference is invited to this Ministry's letter No. 9-69/2009-SP.I dated 29th November, 2010 and letter No. 8-20/2014-SP-III dated 15th October, 2014 wherein IOA and NSFs were asked to furnish the information to this office and to suo-moto disclose their various activities carried out by them. All these instructions have also been made part of the National Sports Development Code of India, 2011 (copies enclosed)


2. It has been noticed that although some of the NSFs are furnishing the required information to this office, it is not available on the websites of many NSFs and hence is not available to general public and stake holders.

3. In a recent case of Badminton Association of India vs. Union of India, the Hon'ble High Court of Delhi has taken a serious view about non furnishing of information under RTI Act by the NSFs. Hence the court has passed an order dated 24th December, 2014 in W.P.(C) No.9318/2014 stating, inter-alia, that this would be an appropriate case where Government of India should examine the manner in which the NSF is functioning.

4. Therefore, in order to reduce the paper work of NSFs while making the information available to stakeholders regarding the functioning of NSFs and IOA it has been decided that henceforth the information as per the enclosed list shall be uploaded on the website of IOA and the respective NSFs.

5. All these information should be made available on the website latest by 1.4.2015. Further, the website must be updated by IOA & NSFs as frequently as possible and atleast once in a fortnight.

6. Vide order No.8-20/2014-SP-III dated 15.10.2014 it was informed that the NSFs shall post their audited accounts and the Balance Sheet of the previous year by 30th June of the current year. It was brought to the notice of this Ministry that finalisation of audited



accounts and balance sheet takes time and it is not possible to post the same on the website by 30th June. In view of this, it has been decided that the annual accounts of the previous financial year should be posted by the IOA & NSFs during the current year as soon as it is finalised but latest by 31st December of the current year.


7. Consolidated list of information to be uploaded on the website of IOA & NSFs is enclosed.
