3. The name of the trust shall be known as "Special Olympics Bharat".
4. The Registered Office of the Trust shall be at X- 14, Lower Floor, Green Park Main, New Delhi 110 016, or such other place(s) within the National Capital Territory of Delhi as the Trustees may from time to time decide.

5. Accounting year:

The Accounting Year of the Trust shall end on 31 March of every year or as maybe prescribed by law from time to time.

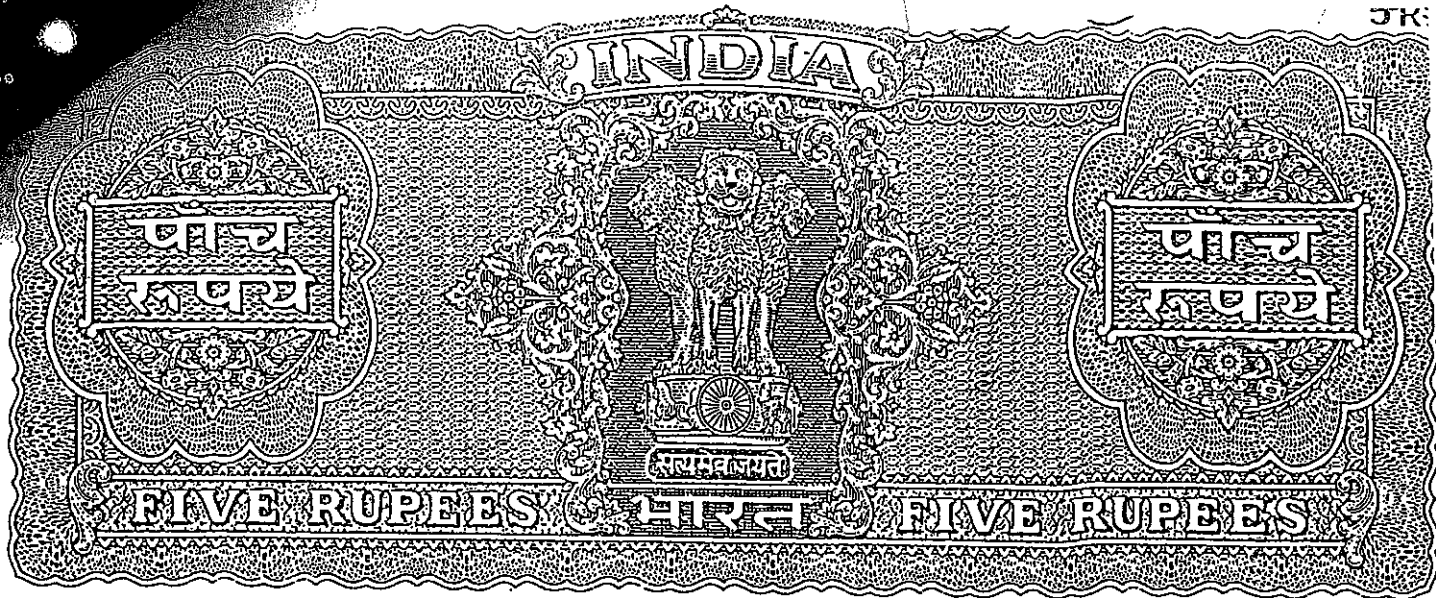
6. Objectives of the Trust:

- a) To manage Trust funds given in the name of Special Olympics Bharat, and raise funds, collect and recover such sums of money, funds, assets, the interest, dividends, income and profits thereof and to pay there from the expenses of collection and other outgoings, liabilities, costs and past losses and deficits, if any.
- b) To apply, pay or utilise the balance of such income, interests, dividends, and profits / surplus of the Trust and the corpus of the Trust or any part thereof for all or any one or more of the objects of the Trust.
- c) To promote, sponsor, start, facilitate, organise or conduct the following activities in the spirit of the Mission Statement of the Special Olympics Official General Rules, which is:

"The mission of Special Olympics is to provide year-round sports training and athletic competition in a variety of Olympic-type sports for children and adults with mental retardation, giving them continuing opportunities to develop physical fitness, demonstrate courage, experience joy and

participate in a sharing of gifts, skills and friendship with their families, other Special Olympics athletes and the community."

d) Trust activities shall include:

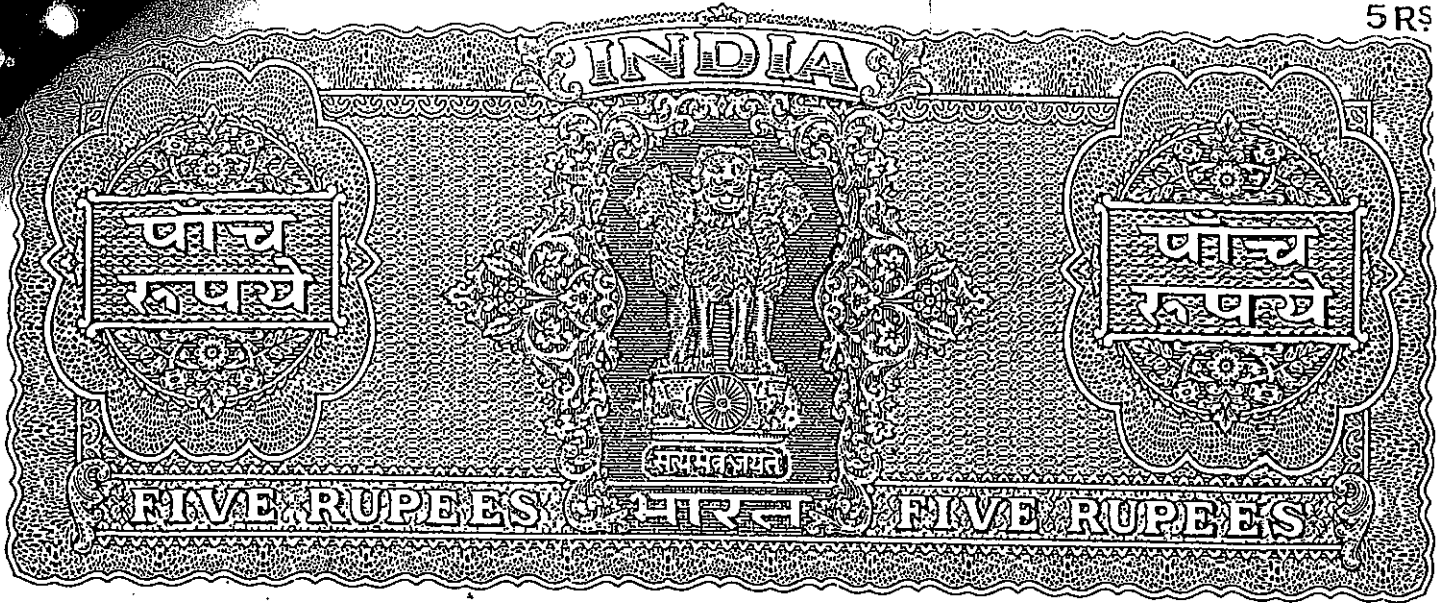
- (i) Athletic activities including sports, training and competitions, games, exercise programs and fitness programs for the persons with mental retardation or intellectual disability on a year-round basis, irrespective of caste, creed, or religion, both within India and on an international level.
- (ii) Organising and operating A "Special Olympics Program" throughout India at National, State, and Local levels.
- (iii) Physical training and educational programs for persons with mental retardation or intellectual disability to develop their minds and bodies.

e) To impart knowledge of Special Olympics :

- (i) By printing and publishing, distribution and selling books, periodicals, pamphlets, leaflets, and magazines, relating to the objects of the trust.
 - (ii) By holding sports meets, demonstration/classes, exhibitions, conducting seminars, symposiums, lectures etc.
- f) To undertake any of the aforesaid activities singly or with the help of individuals, or institutions or organisations, and enter into collaborations, agreements, understandings for the objects of the trust.
- g) To receive monetary or in kind, any help or assistance, co-operation, grants and donations from any person, body or persons, institutions, organisations, who are in sympathy with the aims and objects of the Trust.
- h) To make contributions, provide assistance, whether monetarily or otherwise keeping in view the objects of the trust.

- i) To collaborate, sponsor or obtain sponsors for any activity, programme or project related to the ideals of Special Olympics.
- ii) To do and cause to be done all such other lawful acts, deeds and things according to the objectives of the Trust and Special Olympics Official General Rules.

All the incomes, earnings, moveable or immovable properties of the trust shall be solely utilised and applied towards the promotion of the objects of the trust and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonus or profit or in any manner whatsoever to the present or past trustees. No trustee shall have any personal claim on the moveable or immovable properties of the trust or make any profit, whatsoever by virtue of being a trustee.

7. Trustees :

- a) Air Marshall Denzil Keelor Keelor , (Retd) AVSM, PVSM, Kc, Vrc shall be the first trustee. He shall be the first Chairperson and will appoint the other trustees after submission of the trust deed for registration.
- b) The Trustees who are then the current members of the Board of Trustees will elect trustees.
- c) The tenure of office of each trustee shall be for an initial three years term. A trustee may be elected for a second term of three years. Under extenuating circumstances as determined solely by the Board of Trustees, a Trustee may be elected to a third three year term, but no Trustee may hold tenure beyond a maximum of nine consecutive years.
- d) A former Trustee may be eligible for election to the Board by agreement of the other Trustees after a break of not less than two years.

- e) Trustees may elect additional Trustees by a majority vote in accordance with the interests of the Trust, including the appointment of a Special Olympic Athlete.
- f) Trustees should give due weight to the balance of the membership of the Board by including members with diverse geographic and professional backgrounds who have experience in Special Olympics or mental retardation and by considering gender, special requirements, business/sponsorship experience and the experience and skill of the members. Among the Trustees there shall be at least one sports expert, one parent of an intellectually disabled person, and one expert in mental retardation (e.g., a professional working in the field of Intellectual Disability or Special Needs).
- g) No person shall be appointed or hold a position as a Trustee who shall be in the full-time or part-time salaried employment of Special Olympics Bharat.
- h) Trustees shall not be remunerated for their services. They may be reimbursed for reasonable out of pocket expenses for attending meetings of the Board and while conducting and / or attending to the business of the Trust.
- i) The remuneration of any employee or consultant or advisor of Special Olympics Bharat must not exceed the remuneration that would be payable for similar services by similar organisation(s) for services in India.
- j) If any Trustee shall die or go to reside abroad, or desire to retire, or refuse to act, or become incapable of acting, or take the benefit of the insolvency law for the time being; then in any such case, or for any other reason which the Board deems appropriate with or without cause, it shall be lawful for the other Trustees, including the last surviving Trustee, acting by majority vote, to remove such Trustee at a meeting of the Board, and to elect a new Trustee in place of the Trustee so removed.

- k) Upon every such election of a new Trustee, the Trust fund shall be transferred so as to become vested in the new Trustee(s) jointly with the continuing Trustees. Such newly elected Trustee(s), shall have all the powers and authorities in accordance with all the other continuing Trustees.

- l) The number of Trustees shall not be less than eight and not more than twelve.

8. Officers of the Board:

- a) At the first meeting of the Board following the Annual General Meeting, the Trustees shall elect the following officers from amongst the Trustees
- i) Chairperson
 - ii) One Senior Deputy Chairperson
 - iii) A Treasurer, who is delegated the task of supervising the budget and financial responsibilities of the Board.

- b) The trustees could elect from amongst themselves, Trustees who could be made responsible for chairing designated Zone committees in India.

- b) The Chairperson and the Senior Deputy Chairperson will be eligible for re-election, but each must relinquish that position after a maximum of three years tenure in any of those offices.

9. Executive Director

- a) The Trustees shall recruit and appoint an Executive Director who may be a volunteer or employed on a part-time or full-time basis as designated by the Board and who shall have the authority and responsibility to manage the day-to-day affairs of Special Olympics Bharat.

- b) The Board shall provide an appropriate Job Description for the position of Executive Director, which shall include the duty of acting as Secretary to the Board.

- c) While the Executive Director attends all meetings of the Board, unless otherwise determined by the Board, he/she shall have no voting rights on decisions of the Board.

10. Patron(s) of Special Olympics Bharat

- a) There may be one or two Patrons appointed by the Trustees. The Patron(s) shall hold office at the invitation of the Board for a term of upto three years or for other such periods as the Board decides. A Patron shall be appointed on the basis of his/her willingness and ability to actively promote the objectives of Special Olympics Bharat.
- b) Patrons shall be eligible to be re-appointed by the Board to the position of Patron for a further period of three years, but not exceeding a total of six years.
- c) Patrons shall be entitled on request to receive notice of all meetings of the Board.
- d) While Patrons may attend and speak at meetings, they have no voting rights.
- e) Patrons may resign by written notice to the Board, and such notice shall take effect as soon as the Board accepts the resignation.

11. Committees of the Board

- a) **Executive Committee** : The Trustees may appoint among themselves an Executive Committee that carries out such work as delegated by the Board through the Chairperson, upto and including all the powers of the Board at any time when the Board is not in session, as specified by the Chairperson in writing. The Committee may consist of any number of Trustees as approved by Board. The tenure of this committee shall be determined by the Board of Trustees, from time to time, who can amend the tenure, powers, terms, of reference and any other aspects related thereto.
- b) **Other Committees** : The Board may appoint other Committees as the need arises, to act under the authority delegated by the Board. Members of such other Committees (which do not include the Executive Committee), may be appointed to that Committee from outside the membership of the Board.
- c) Any Committee appointed shall be subject to any general or special direction(s) given, or conditions attached by the Board and shall undertake duties and have authority and responsibility so delegated by the Board.

- d) The Board shall in all cases, have and retain the right to revoke or dissolve the appointment of any Committee and to revoke, amend or modify the delegation to any Committee of any duty or authority of the Board.
- e) Unless otherwise provided by the Board every such Committee shall act only with a quorum of a majority of Members of that committee.
- f) Each Committee shall report to the Board and seek approval prior to the implementation of plans and actions, unless prior approval has already been granted.
- g) The tenure of a committee shall be determined by the Board of Trustees, from time to time, who can amend the tenure, powers, terms, of reference and any other aspects related thereto.

12. Meetings of the Board :

- a) A minimum of four (4) meetings shall be held each Calendar year to conduct the business of the Board of Special Olympics Bharat.
- b) One of these meetings shall be designated by the Board as the Annual General Meeting, at which the following shall take place:
 - i) Receipt of the Chairperson's Annual Report.
 - ii) Receipt and Approval of the Audited Accounts and Financial Reports of the Treasurer to the Board.
 - iii) Election of Officers of the Board
 - iv) Other business as has been duly notified to Trustees as agenda items, with a minimum of 21 days notification to the Trustees.
- c) **Special General Meetings of the Board:** By giving a minimum of 21 days notice, a Special General Meeting of the Board may be called by the authority of the Chairperson, or by a set of four Trustees requesting such a meeting in writing. The Agenda item or items so designated shall be the only items of business approved for discussion and agreement at such a Special General Meeting.
- d) **Quorum for Meetings of the Board:** The quorum of the Board for any meeting to proceed shall be a minimum of fifty (50) percent of the full number of Trustees of Special Olympics Bharat then in office.
- e) At the final regular meeting of the Board in a Calendar year the Board shall set the meeting dates for the regular meetings and Annual General Meeting in the next Calendar year. These shall be followed up with a notification of each meeting to each trustee no less than 21 days prior to the meeting.

Such notification shall include the Agenda items for discussion plus supporting information and the Minutes of the previous meeting. The day, date, time and venue must be specified in any notice concerning a meeting. Except at any Special General Meeting, other items may be added to the Agenda at a Board meeting, subject to the approval of the Board.

- f) Notice & Convening of Meetings: All meetings of the Board, the General Meetings or Special General Meetings shall be convened by the Chairperson. If the Chairperson fails to act then the notice convening the meeting can be issued under the joint signatories of four trustees. The notices will be sent to the trustees and members (as the case maybe) at the address registered with the office of Special Olympics Bharat.

13. Administration of Special Olympics Bharat

- a) Special Olympics Bharat shall be administered by the duly elected Trustees.
- b) The Board shall have prepared and approve an "Administrative Manual" for Trustees and Staff employed by the Board to be followed. Such Administration Manual shall follow the principles and practises to achieve the established objectives of the Trust.
- c) The Administration Manual may be amended at any meeting of the Board for which due notice of the proposed amendment has been given to the Trustees.

14. Voting at Meetings of the Board

- a) At any duly constituted meeting of the Board where a decision is made by a vote of the Trustees, where a tie vote is recorded, the Chairperson of the Board, or in the absence of the Chairperson, his/her Deputy acting in place thereof shall have an additional casting vote.
- b) The Board may from time to time approve the use of written proxy votes from Trustees granted leave of absence by the Chairperson.
- c) The Board may from time to time authorise and conduct a written ballot of Trustees by post, or by other means approved by the Chairperson on urgent items where a decision is needed but the Board may not be able to meet in time. Such items would be authorised in advance by the Executive Committee and require the affirmative written approval of a majority of Trustees then in office.
- d) All meetings of the Board, the Executive Committee will be chaired by the Chairperson. In his absence, the Deputy Chairperson shall be elected as

Chairman of the meeting. If neither is present then the trustees shall elect one amongst themselves to be the Chairman of the meeting.

15. Attendance at Meetings

- a) A Trustee who is not able to attend a meeting shall notify the Chairperson or the Executive Director and seek leave of absence from the meeting.
- b) A Trustee who is absent from three consecutive meetings in a year shall be deemed to have resigned his or her position as a Trustee unless extenuating circumstances exist and the other Trustees present at the meeting grant leave of absence.

16. Records, Books of Accounts and Audit

- a) All records, minute books, title deeds, securities, account books, vouchers, papers and documents relating to the Trust of Special Olympics Bharat, shall remain in the custody of such person or persons at the administrative office of Special Olympics Bharat or at such other place or places that the Board may determine from time to time.
- b) The account books shall be open for inspection during normal business hours on prior written notice being given to the Chairperson or Executive Director.

17. Financial Management of the Board for the Special Olympics ^{BHARAT} Trust : *Sharma*

- a) The Board through delegated authority to the Treasurer shall ensure the keeping of proper books of accounts and records in which all receipts and payments; assets and liabilities relating to the Trust shall be entered.
- b) The Trust Fund shall be administered and managed in accordance with provisions contained in this Trust Deed and Constitution, the Special Olympics Official General Rules, and such additional rules and regulations as the Trustees may adopt that are consistent with the objectives of the Trust and the laws of the Republic of India.
- c) The Board shall in each financial year have made and prepared an accurate and complete Balance Sheet and Statement of Income and Expenditure that shall include all proper accounts of receipts and payments in connection with the Management of the Trust for the preceding year and such accounts shall be audited by the Chartered Accountant to be appointed by the Board as required and in accordance with all Statutory requirements and submitted to the Board for review and approval. A copy of the Balance Sheet and Statement of Income and Expenditure shall be posted to each Trustee and also to Special Olympics Inc., as required under the Special Olympics Official General Rules for each accredited Special Olympics Program.

- d) The financial management shall be supported by a "Financial Manual" which shall be developed and approved by the Board to provide specific guidelines for the day-to-day and annual management of the Financial affairs of the Special Olympics Bharat Trust, including reliable internal control systems for protecting, recording and accounting for the receipts and expenditures of the funds.
- e) All monies that are received by the Trust shall be duly receipted and faithfully recorded.
- f) Monies received from sources outside the Republic of India must be banked in such accounts as required by the relevant authority of the Government of India.

18. Payment and Reimbursement of Expenses

Trustees are entitled to be reimbursed for reasonable and necessary expenses incurred in connection with their duties as Trustees and to pay and discharge out of Trust funds all expenses incurred in or about the execution of the Trust and the powers vested from it.

19. Liabilities of Trustees / Members of the Board

A Trustee shall be liable only for such money, funds, deposits, securities and other assets which the Trustee actually receives and shall be answerable only for his or her own acts; criminal acts; dishonesty, or wilful act that constitutes a breach of trust.

20. Contributions, Collections and Donations :

The Trustees may receive any voluntary contribution(s) from the public for the objectives of the Special Olympics Bharat Trust provided they are not inconsistent with the laws of the Republic of India and are consistent with the Special Olympics Official General Rules.

21. Bank Accounts

- a) All monies collected by or on behalf of the Trust shall be immediately paid into a Special Olympics Bharat Trust Bank Account with the exception of the account needed to receive monies from outside the Republic of India, which shall be deposited in the designated bank account.
- b) Money shall not be withdrawn from the Trust accounts without the authority of the Board and in accordance with the financial guidelines adopted by the Board and outlined in the Financial Manual.

22.Trust Fund: Investment

Investment of Trust assets shall be undertaken by appropriate approval of the Board in accordance with the laws of Republic of India and as applicable to a Trust, especially as specified under the Income Tax Act 1961.

23. Rules and Regulations:

The Board of Trustees is entitled to make Rules and Regulations for the Management of the Trust and all matters concerning the Trust and Trust assets, including the conduct of meetings of the Trustees, provided such Rules and Regulations shall be consistent with the provision of this Trust Deed and Constitution and the objectives of the Trust.

24.Amendments to the Trust Document/Constitution

- a) This Trust Deed and Constitution may be altered, added to, rescinded or otherwise amended by a three quarter majority of Trustees then in office at any meeting of the Board, provided that notice convening such meeting shall set forth the purpose of such alterations and provided further that any alteration to this Constitution shall not be inconsistent with the charitable nature and objectives for which the Special Olympics Bharat Trust was established.
- b) Duplicate / original copies of every such alteration, additions, rescission or amendment to this Constitution shall forthwith be delivered for registration in accordance with the laws of the Republic of India.

25.Appointment of staff, Advisors, and Legal Committees:

The Chairperson / Trustees shall be entitled at their discretion to employ solicitors, attorneys and legal advisors and other persons, and appoint legal committees at any place or places for carrying out the objectives of Special Olympics Bharat Trust and to pay out of the Trust funds any reasonable resulting charges, including travel and other expenses, remuneration, fees and salary to any person so appointed to do any act(s). If any Trustee is engaged in any profession or business or is member of any Firm or Agency employed by the Board, that Trustee shall declare his or her interest in the same and take no part in decisions that may affect the business or any changes as concerned.

26.Dissolution and disposal of funds:

No resolutions for dissolving Special Olympics Bharat Trust shall take effect unless consented to by at least three-quarters of the Trustees then in office at either an Annual General Meeting or other Special General Meeting either convened for that purpose or in which the notice summoning such

meeting includes the intention to move such a resolution or unless an instrument of dissolution is duly executed by at least three quarters of such Trustees and confirmed in any case at a further Special Meeting to be held not before the 28th day and not later than the 42nd day after the date the first resolution was passed and in respect of which due notice has been given to dissolve Special Olympics Bharat Trust and such confirming resolution is passed by a three-quarter majority of the Trustees then in office. Should Special Olympics Bharat Trust be dissolved then any money and other property remaining after the due settlement of the Trust's affairs, and the payment of all valid debts and claims of the Trust, shall be distributed to some other entity or organisation that has the same or nearly the same objectives as the Trust, subject to any order of the High Court of India in accordance with the laws of the Republic of India.
