Sir.

The matter regarding renewal of recognition to School Games Federation of India (SGFI), which was suspended vide Letter No. 80-6/2017-SP III dated 25.02.2020, has been examined. The suspension of recognition of SGFI has already been revoked, vide letter of even number dated 12.11.2020. The last election of office bearers of the Federation held on 25.06.2016 for the term 2016-2020 was taken on record by the Ministry. The elections of the Executive Committee of SGFI for the next term i.e. 2020-2024 have become due.

- 2. The matter regarding elections of NSFs which have not been conducted during the country-wide lockdown imposed to contain the spread of COVID-19 pandemic have been looked into by the Ministry. The restrictions imposed are being relaxed in phased manner by re-opening of activities outside the containment zone. Also under the latest guidelines issued by Ministry of Home Affairs social/academic/sports/entertainment/cultural/religious/political functions and other congregations have been permitted with a ceiling of 100 persons. However, directives for COVID-19 management are to be followed mandatorily. In the circumstances, it has been decided that School Games Federation of India shall conduct election of its executive body by 31.12.2020, following the Model Elections guidelines prescribed in the National Sports Development Code 2011.
- 3. Upon consideration of the entire matter, it has also been decided to grant recognition to School Games Federation of India up to 31.12.2020.
- 4. It has been noticed that constitution / MoA of the School Games Federation of India needs to be aligned with the provisions of the National Sports Development Code of India, 2011 (Sports Code). Accordingly, the School Games Federation of India is required to make categorical affirmation of the provisions of the Sports Code in its constitution within 6 months so as to bring the same fully in line with the Sports Code. The Federation is also required to take necessary steps for uploading of the information in compliance to the instructions as contained in this Ministry's



letter no. 9-7/2014-SP.I dated 26.02.2015 on suo-moto disclosure within 3 months' time (copy enclosed).

Sub: Information to be hoisted mandatorily by IOA & NSFs on their website - reg.

Sir.

Reference is invited to this Ministry's letter No. 9-69/2009-SP.I dated 29th November, 2010 and letter No. 8-20/2014-SP-III dated 15th October, 2014 wherein IOA and NSFs were asked to furnish the information to this office and to suo-moto disclose their various activities carried out by them. All these instructions have also been made part of the National Sports Development Code of India, 2011 (copies enclosed)

- 2. It has been noticed that although some of the NSFs are furnishing the required information to this office, it is not available on the websites of many NSFs and hence is not available to general public and stake holders.
- 3. In a recent case of Badminton Association of India vs. Union of India, the Hon'ble High Court of Delhi has taken a serious view about non furnishing of information under RTI Act by the NSFs. Hence the court has passed an order dated 24th December, 2014 in W.P.(C) No.9318/2014 stating, inter-alia, that this would be an appropriate case where Government of India should examine the manner in which the NSF is functioning.
- 4. Therefore, in order to reduce the paper work of NSFs while making the information available to stakeholders regarding the functioning of NSFs and IOA it has been decided that henceforth the information as per the enclosed list shall be uploaded on the website of IOA and the respective NSFs.
- 5. All these information should be made available on the website latest by 1.4.2015. Further, the website must be updated by IOA & NSFs as frequently as possible and atleast once in a fortnight.
- 6. Vide order No.8-20/2014-SP-III dated 15.10.2014 it was informed that the NSFs shall post their audited accounts and the Balance Sheet of the previous year by 30th June of the current year. It was brought to the notice of this Ministry that finalisation of audited

accounts and balance sheet takes time and it is not possible to post the same on the website by 30th June. In view of this, it has been decided that the annual accounts of the previous financial year should be posted by the IOA & NSFs during the current year as soon as it is finalised but latest by 31st December of the current year.

- Consolidated list of information to be uploaded on the website of IOA & NSFs is enclosed.
- 8. It is also informed that annual recognition for the year 2015 may be reviewed in case the above instructions are not complied with by 1.4. 2015.


