Subject :- Suspension of Paralympic Committee of India- reg

Whereas the Paralympic Committee of India (PCI) has been recognized as National Sports Federation (NSF) for Para-sports in the country.

2. Whereas the last elections of PCI were held in September 2019 but due to order passed by the Hon'ble Delhi High Court in W.P. No. 10647/2019 staying the notification of election dated 03.09.2019 and the Returning Officer was also restrained from declaring the result of the elections. As such, the results of election were not declared. The Hon'ble Delhi High Court vide order dated 27.01.2020 in W.P. No. 10647/2019 allowed the declaration of results of the election notified on 03.09.2019 subject to the further orders to be passed in the said petition. In pursuance of the above order of Hon'ble Delhi High Court, the Returning Officer declared the results of election on 31.01.2020. So, four year term of the Executive Committee of PCI has ended on 31.01.2024.

3. Whereas the elections for electing new Executive Committee should have been held before the expiry of the term of the previous Executive Committee. However, PCI has vide notice dated 22.01.2024 announced that the elections will be held on 28.03.2024 at Bengaluru, which indicates a substantial gap of almost two months after the expiry of the term of the previous Executive Committee. This decision of the PCI is in violation of the provisions of the PCI's own constitution as well as the provisions of the Sports Code.

4. Whereas the Ministry vide circular no. 29-16/2014-SP-III dated 10.02.2015, with a view to impress upon the NSFs to hold the elections in time, has directed IOA and all NSFs that elections to elect new office bearers shall be conducted at least one month before the expiry of the term of the office bearers.

5. Whereas the Constitution of PCI (para 12.1.4) provides for holding election of the Governing Board Members every four years. Further, para 15.1 of PCI's Constitution provides that PCI's election procedure (once in 4 years) shall be followed as per Govt. of India's National Sports Development Code, 2011 (NSDC) Guidelines.

6. Whereas the PCI was well aware of the fact that the term of the Executive Committee was only up to 31.01.2024, its decision to hold the election on 28.03.2024 is wilful, intentional and without any valid reason. Such failure undermines the democratic process and the principles of good governance as mandated under the National Sports Development Code of India. Compliance with the Sports Code is imperative to ensure transparent and democratic governance in Indian Sports in a legally sound framework, at par with the other National Sports Federations.

7. Whereas the Sports Code provides for suspension/withdrawal of the Government recognition. Among the grounds for suspension, the following are included: "

iv. failure to hold elections as prescribed in the constitution of the NSF or in accordance with the government guidelines or gross irregularities in election procedures.

ix. Non-compliance with the conditionalities laid down by the Government.

8. Whereas taking note of the intentional delay by the PCI in the conduct of the election to elect a new executive committee, vis a vis the essentiality of upholding good governance and accountability standards in sports federations nationwide and the requirements of all the NSFs, NOC, NPC to adhere strictly to the Sports Code, the Government is left with no choice but to suspend the recognition of PCI with immediate effect till further orders. Considering the fact that the PCI acts as an NPC as well as an NSF for a few disciplines, the Sports Authority of India (SAI) is hereby directed to coordinate with the International Paralympic Committee (IPC) to form an Ad Hoc Committee comprising eminent administrators and sportspersons to undertake these tasks performed by PCI to safeguard the interests of the Indian para-sportspersons and the para-sports disciplines, who will oversee the operations of the PCI, and conduct free, fair and transparent elections as per the extant instructions under the Sports Code along with the constitution of the PCI.

I am directed to refer to this Department's Order of even number dated 02.02.2024 regarding suspension of the government recognition of Paralympic Committee of India (PCI) due to delay in holding the election after expiry of the term of the Executive Committee of PCI. Subsequent to issue of aforesaid order of suspension, PCI has vide its Election Notice dated 15.02.2024, announced that the elections will be held on 09.03.2024 at New Delhi. The Returning Officer for election of PCI has vide notification dated 04.03.2024, notified the list of unopposed candidates deemed to be duly elected, in terms of Article 9 sub clause (1) of Model Election Guidelines (Annexure-XXXVII of the Sports Code 2011), which provides that "where the number of contesting candidates for any post, in Form-6, is equal to the number of the posts to be filled, all such contesting candidates shall be deemed to be duly elected unopposed to those sports, and it shall not be necessary to take a poll for election to such posts".

2. Considering that the main ground for suspension of Government recognition of PCI was delay in holding the election after expiry of the term of the EC of PCI, and that since the election process has reached the stage where the nominated candidates have been deemed to be duly elected unanimously; as well as the important fact that PCI is hosting 2024 World Shooting Para Sport World Cup from 06 - 15 March, 2024 at New Delhi, it has been decided to revoke the suspension of PCI, with immediate effect.
