**Subject:-** Payment of grants-in-aid to Directorate of Sports and Youth Welfare Madhya Pradesh towards incurring expenditure on organizing Women Competitions during 2013-14 under PYKKA scheme.

Sir,

I am directed to convey the approval of the competent authority for payment of a sum of ₹ 35,47,329/- only (rupees thirty five lakh forty seven thousand three hundred twenty nine only) to the Directorate of Sports and Youth Welfare, Madhya Pradesh for organizing Women Sports Competitions at district and state level under PYKKA Scheme, during 2013-14, as PYKKA GIA-General, out of total admissible grant of ₹54,99,735/- only (Rupees fifty four lakh ninety nine thousand seven hundred thirty five only). Details are given in the Annexure.

2. The amount sanctioned herein will be placed at the disposal of the Directorate of Sports and Youth Welfare, Madhya Pradesh by Principal Accounts Office (Min. of H.R.D.) New Delhi immediately and not later than 31<sup>st</sup> March 2014.

3. The grant is subject to the conditions mentioned below:-

- (i) Amount of Grants-in-aid should be utilized only for the purpose for which it is sanctioned and unspent balance of Grants-in-aid shall be refunded by the grantee institution immediately after conducting the programme.
- (ii) Institutions or Organizations receiving grants, irrespective of the amount involved, are required to maintain subsidiary accounts of the Government grants and furnish to the Accounts Officer a set of audited statements of accounts after utilization of the Grants-in-aid or whenever called for. Interest will be charged @ 10% p.a. in case of non-compliance of this requirement.
- (iii) The accounts of all grantee institutions/organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry or Department whenever the institution or organization is called upon to do so.
- (iv) The institution/organization seeking Grants-in-aid should also certify that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
- (v) The Grants-in-aid is further subject to the conditions laid down in General Financial Rules as amended from time to time.
- (vi) The grantee will promote HIV/AIDS Awareness.



- (vii) The action photographs and the press clippings/CD's of the competitions may also be submitted to this Ministry along with the UC and other details.
  - (viii) The Directorate of Sports and Youth Welfare Madhya Pradesh will conduct the Women Sports Competitions as per the calendar of competitions/proposal submitted by it and in case of any change the same will be intimated immediately to this Ministry.
  - (ix) The Directorate of Sports and Youth Welfare Madhya Pradesh will be liable to refund the entire grant released to it within the same financial year, in case the lower level competitions are not conducted or the competitions are conducted after the national level women competitions for 2013-14.
  - (x) The Directorate of Sports and Youth Welfare Madhya Pradesh will be liable to refund the entire grant released to it for conduct of women sports competitions, in case, it fails to participate in the national level women competitions for 2013-14.
  - (xi) This is a **recurring grant**. The grantee shall submit the Utilization Certificate (UC) in the prescribed format immediate after closure of the financial year. The utilization certificate should be checked and signed an officer not below the rank of Director and countersigned by the Secretary (Sports) Govt. of Madhya Pradesh. The subsidiary accounts of the Govt. grant to be maintained by the grantee as per Rule 210 of the GF Rules 2005. Grant-in-aid sanctioned for the subsequent financial year shall be released only after receipt of the utilization certificate in respect of the grants of the preceding financial year.
  - (xii) The fact that the programme is sponsored by the Ministry of Youth Affairs and Sports should be prominently highlighted and displayed while inviting people and holding functions/programmes/events etc.
  - (xiii) When the Government of India has reasons to believe that the sanctioned grants-in-aid is not being utilized for the approved purpose, the payment of the grant shall be stopped. If the reply to the show cause notice is not satisfactory, the earlier grant will be recovered with interest.
  - (xiv) The Grantee institution or the organization should exercise reasonable economy in implementing of the approved programme.
  - (xv) No assets should be created out of this grant.
4. It is certified that, no Utilization Certificate (UC) is pending against the Directorate of Sports and Youth Welfare Madhya Pradesh in respect of the grant released to it during the previous year(s) under PYKKA scheme.
5. It may be ensured by the Directorate of Sports and Youth Welfare Madhya Pradesh that the sanctioned programme is started within one month from the date of receipt of the funds and the grants-in-aid is utilized before 31<sup>st</sup> March 2014.
6. The sanction is being issued in exercise of the delegated powers and in conformity with the rules and principles as approved by the Ministry of Finance. It is also certified that the pattern of assistance has the approval of the competent authority.
7. On receipt of sanction letter, the Principal Accounts Office (Min. of H.R.D.) may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit to the concerned balance of the State Govt. concerned. Principal Accounts Office (Min. of H.R.D.) may forward a copy of the advice to the Accountant General Govt. of Madhya Pradesh and Finance Department of the Govt. of Madhya Pradesh along with the copy to undersigned.
